USG ABDOMEN AND PELVIS

LIVER: Liver is normal in size measuring 13.5 cm & shows normal echo texture. No evidence of any diffuse or focal pathology. Intrahepatic biliary radicals are not dilated. Portal vein & CBD are normal in diameter.

GALL BLADDER: is well-distended. No evidence of calculus or mass. Gall bladder wall thickness is normal.

PANCREAS: is normal in size and echo texture. Pancreatic duct is not dilated.

SPLEEN: Spleen is normal in size measuring 9.2 cm & shows normal echo texture. No evidence of any focal lesion.

KIDNEYS:

Right Kidney measures 10.5 x 4.9 cm in size.

Left Kidney measures 9.8 x 5.3 cm in size.

Both kidneys are normal in size and echo texture. Corticomedullary differentiation is normal. No evidence of calculus or hydronephrosis on both sides.

Urinary Bladder is Well-distended.

IVC and aorta are normal. No Para aortic lymphadenopathy.

No evidence of any intra- abdominal or pelvic mass.

No e/o any free fluid in abdomen and pelvis.

High resolution USG was performed with high frequency linear transducer, which reveals normal bowel loops and mesenteric structures. No evidence of significant mesenteric lymphadenopathy.



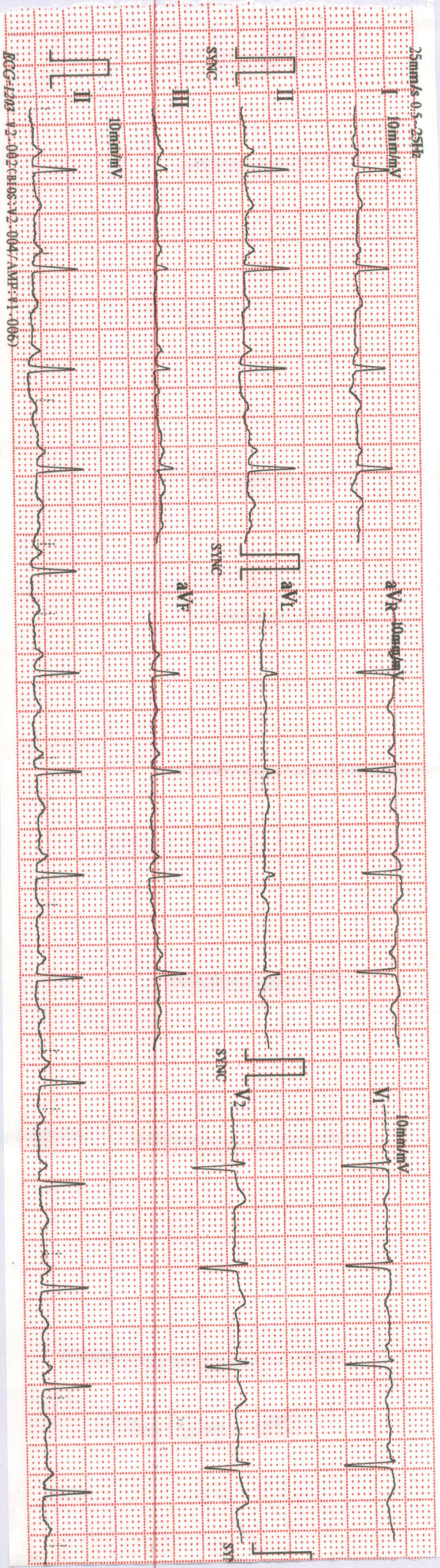

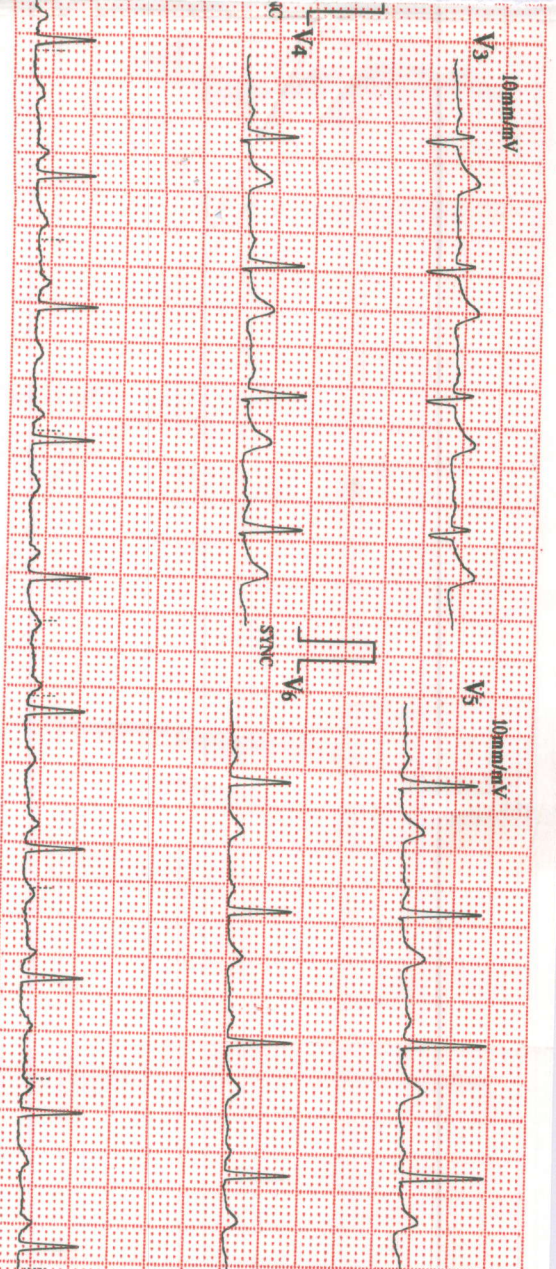
