**EXTENSION AGREEMENT TO THE MOU AGREEMENT DATED 30
DAY OF MARCH 2022**

This Extension Agreement is entered into on this 1st day of April, 2024

By and Between

Suburban Diagnostics (India) Pvt Ltd, a Company having its Registered Office at 2nd Floor, Aston, Sundervan Complex, Lokhandwala Road, Andheri (West), Mumbai - 400053, Maharashtra, India (hereinafter called "**SDIPL**") which expression shall unless repugnant to the context or meaning thereof include its affiliates, successors and permitted assigns of the ONE PART;

And

Arcofemi Healthcare Pvt Limited a Company incorporated under the laws of India and having its Registered Office at F 701 A Lado Sarai, New Delhi and Corporate Office at F 701 A Lado Sarai, New Delhi (hereinafter referred to as the "**MediWheel**"), which expression shall, unless repugnant to the context thereof, mean and include its successors and permitted assigns of the OTHER PART.

"**SDIPL**" and "**MediWheel**" are hereinafter referred to individually as "Party", and collectively as the "Parties".

PREAMBLE

WHEREAS SDIPL and MediWheel have executed a MOU Agreement dated 1 March 2021 (hereinafter referred as "**Principal Agreement**").

WHEREAS both the Parties desire and agree to extend the Term of the Principal Agreement for which purpose this Extension Agreement is being executed (hereinafter referred to as "**Extension Agreement**") subject to terms and conditions contained hereinafter.

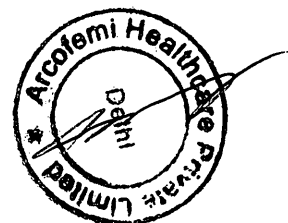
Now, therefore, in consideration of the mutual premises and the mutual covenants herein contained, the Parties agree as follows.

1. Scope of the Extension Agreement:

1.1 It is agreed between the Parties to extend the Term of the Principal Agreement for further period of 3 Years from the Expiry Date of Principal Agreement (hereinafter referred to as "**Extended Term**").

2. Miscellaneous

2.1 This Extension Agreement is in the nature of an addition to the Principal Agreement and all capitalized terms not otherwise defined in this Extension Agreement shall have the meanings as set forth in the Principal Agreement.




- 2.2 The Parties agree that this Extension Agreement shall be effective from 15th April 2024
- 2.3 Except as expressly modified in this Extension Agreement, the Principal Agreement shall remain unmodified and in full force and effect.
- 2.4 In the event of any conflict between the terms of this Extension Agreement and the Principal Agreement, the terms of this Extension Agreement shall prevail with respect to the subject matter contained herein.
- 2.5 This Extension Agreement shall become an integral part of the Principal Agreement and shall together with the Principal Agreement, represents the complete understanding between the SDIPL and MediWheel with respect to the subject matter hereof.
- 2.6 The Parties agree that the execution of this Extension Agreement and all of its amendments, appendices and other documents to be made under it by exchanging pdf signatures, and/or by industry standard electronic signature software, shall have the same legal force and effect as the exchange of original signatures.
