Re: Extending last date of Mandatory Annual Health Check-up for FY (2022-23)

Our Bank's Mandatory Annual Health Check-up Scheme was introduced with the aim of facilitating timely detection & treatment of health issues of employees & their spouse with scheme details being covered in the circular no. HO:BR:111/116 dated 10.05.2019.

It has been brought to our notice that several employees (and their spouse) have been unable to undergo scheduled health check-ups due to Doctor's Strike in certain parts of the country, with requests being made with respect to extension of health check-up deadline.

In view of the issues being faced by our employees, it has been decided to extend the last date of Mandatory Annual Health Check-up till 15.04.2023 for FY (2022-23) as a special case, provided the registration has been done in HR Connect on or before 31.03.2023. The extension will have no bearing on their eligibility for mandatory annual health check-up for the FY (2023-24).

We trust that the extended timelines shall aid the remaining employees / spouses in availing the Mandatory Annual Health Check-up facility within the stipulated timeline.
