USG ABDOMEN AND PELVIS

LIVER: Normal in size (11.9cms), contour. Intrahepatic biliary radicals are normal. Portal vein appears normal.

An anechoic cystic lesion measuring 1.3 x 1.0cm seen in segment VI of liver without appreciable septae.

A small hyperechoic lesion measuring 1.10 x 1.0mm seen in segment VI of liver with no internal vascularity - hemangioma.

GALL BLADDER: Distended, appears normal. No obvious calculi / pericholecystic fluid seen. Common bile duct is not dilated.

PANCREAS: Normal in size, shape & has uniform echogenicity.

SPLEEN: Normal in size (8.3cms) and echopattern. No focal lesions seen.

KIDNEYS: Both the kidneys are normal in position, size, shape and contour. Cortical echogenicity is normal, corticomedullary differentiation is well maintained.

RT.KIDNEY- 10.1cm in length and 1.3cm in parenchymal thickness. No calculi / hydronephrosis seen.

LT.KIDNEY- 10.2cm in length and 1.6cm in parenchymal thickness. No calculi / hydronephrosis seen.

URINARY BLADDER: Normal in outline and wall thickness. No calculi or mucosal irregularity seen.

PROSTATE: Normal in size and echotexture.

No free fluid / dilated / thickened bowel loops are noted.
