ABDOMINO-PELVIC ULTRASONOGRAPHY

LIVER is normal in shape, size (11.1 cms) and has uniform echopattern. No evidence of focal lesion or intrahepatic biliary ductal dilatation. Hepatic and portal vein radicals are normal.

GALL BLADDER is partially distended. CBD is not dilated.

PANCREAS has normal shape, size and uniform echopattern. No evidence of ductal dilatation or calcification.

SPLEEN show normal shape, size (8.7 cms) and echopattern.

KIDNEYS

Right kidney: Normal in shape, size and echopattern. Cortico-medullary differentiation is well madeout. No evidence of calculus or hydronephrosis.

Left kidney: Normal in shape, size and echopattern. Cortico-medullary differentiation is well madeout. No evidence of calculus or hydronephrosis.

The kidney measures as follows:

URINARY BLADDER show normal shape and wall thickness. It has clear contents. No evidence of diverticula.

(TAS & TVS)

UTERUS is anteverted and has normal shape and size. It has uniform myometrial echopattern. Endometrial echo is of normal thickness - 6.9 mm.

Uterus measures LS: 5.9 cm AP: 3.6 cm TS: 4.7 cm.

OVARIES

Right ovary is bulky and shows a cystic lesion of about 8.0 x 4.1 x 4.4 cms (Volume: 76 cc) with few septations and minimal internal echoes. Few anechoic cystic lesions with internal echoes are also noted in right ovary, largest measuring about 2.1 x 1.2 cms.

Left ovary is bulky and shows a cystic lesion measuring about 3.1 x 3.0 x 2.9 cms (Volume: 14cc) with multiple septations and internal echoes.

POD is clear. No evidence of ascites.
