Method : CLIA.

1) TSH levels are subject to circadian variation, reaching peak levels between 2 - 4.a.m. and at a minimum between 6-10 pm.

The variation is of the order of 50% . hence time of the day has influence on the measured serum TSH concentrations .

2) Recommended test for T3 and T4 is unbound fraction or free levels as it is metabolically active.

3) Physiological rise in Total T3 / T4 levels is seen in pregnancy and in patients on steroid therapy.
