



USG REPORT - ABDOMEN AND PELVIS

LIVER:

Is enlargesd in size ~17 cm and shows increased echo texture.

No obvious focal lesion seen. No intra - Hepatic biliary radical dilatation seen.

GALL BLADDER:

Is adequately distended. No calculus or internal echoes are seen. Wall thickness is normal.

PANCREAS:

Appears normal in size and it shows uniform echo texture.

SPLEEN:

Is normal in size ~10.2 cm and shows uniform echogenicity.

RIGHT KIDNEY:

Right kidney measures ~10.3 x 3.7 cms.

The shape, size and contour of the right kidney appear normal.

Cortico medullary differentiation is within normal. No evidence of pelvicalyceal dilatation.

No calculi seen.

LEFT KIDNEY:

Left kidney measures ~ 9.4 x 3.7 cms.

The shape, size and contour of the left kidney appear normal.

Cortico medullary differentiation is within normal. No evidence of pelvicalyceal dilatation.

Calculus of size measuring ~ 4.2 mm noted in upper pole of left kidney.

USG REPORT - ABDOMEN AND PELVIS

BLADDER:

Is normal contour. No intra luminal echoes are seen.

UTERUS:

Measures ~ 9.2 x 4.2 x 5.6 cms.

Endometrium is regular and normal (5 mm).

Cervix appears normal.

OVARIES:

Right ovary measures ~ 1.8 x 1.3cms.

Left ovary measures ~1.4 x 1.6 cms.

No adnexal mass lesion seen. Pouch of Douglas is free. No free fluid in abdomen.

IMPRESSION:

- Mild Hepatomegaly with grade I fatty liver.
- Non obstructive left intra renal calculus.
