## **USG WHOLE ABDOMEN**

**LIVER:** Liver is normal in size (14.0cm. cranio-caudal), shape and echotexture. There is no intrahepatic biliary radical dilatation. No evidence of any focal lesion.

**GALL BLADDER:** Gall bladder is distended and appears normal. Wall thickness is within normal limits. There is no evidence of any calculus.

**PORTAL VEIN:** Portal vein is normal. **CBD:** CBD is normal.

<u>PANCREAS</u>: Pancreas appears normal in echotexture. There is no evidence of any focal lesion or calcification. Pancreatic duct is not dilated.

**KIDNEYS**: Right kidney measures 10.4 x 3.9cm. Left kidney measures 9.6 x 4.5cm.

Both kidneys are normal in shape and echotexture. Corticomedullary differentiation is maintained. There is no evidence of any hydronephrosis, hydroureter or calculus.

**SPLEEN**: Spleen is normal in size (8.1cm.), shape and echotexture. No focal lesion is seen.

**URINARY BLADDER**: Urinary bladder is distended and normal. Wall thickness is within normal limits.

<u>UTERUS</u>: Uterus is anteverted, normal and measures 5.5 x 5.1 x 3.6cm. Uterine myometrium shows homogenous echotexture. Endometrial echo is in midline and measures 8.0mm. Cervix appears normal.

<u>OVARIES:</u> Both ovaries appear mildly bulky. Both the ovaries show multiple, small (5-8 mm diameter) peripherally arranged follicles and increased echogenicity of central stroma. Findings could be suggestive of polycystic ovaries.

The right ovary measures 3.4 x 3.4 x 1.8cm. and ovarian volume is 11.5cc.

The left ovary measures 3.2 x 3.1 x 2cm. and ovarian volume is 11.0cc.

No free fluid or significant lymphadenopathy is seen.

Kindly correlate clinically and with hormonal correlation for PCOD.
