## ABDOMINO-PELVIC ULTRASONOGRAPHY

**LIVER is normal in size and shows diffusely increased echogenicity.** No evidence of focal lesion or intrahepatic biliary ductal dilatation. Hepatic and portal vein radicals are normal.
