No calculi / hydronephrosis.
- URINARY BLADDER:** Partially Distended. Mural thickness is normal. No Calculi.
- UTERUS** : Retroverted. ET : 7mm
- OVARIES** : Both ovaries appears Normal.
- \*No free fluid noted in peritoneal cavity.

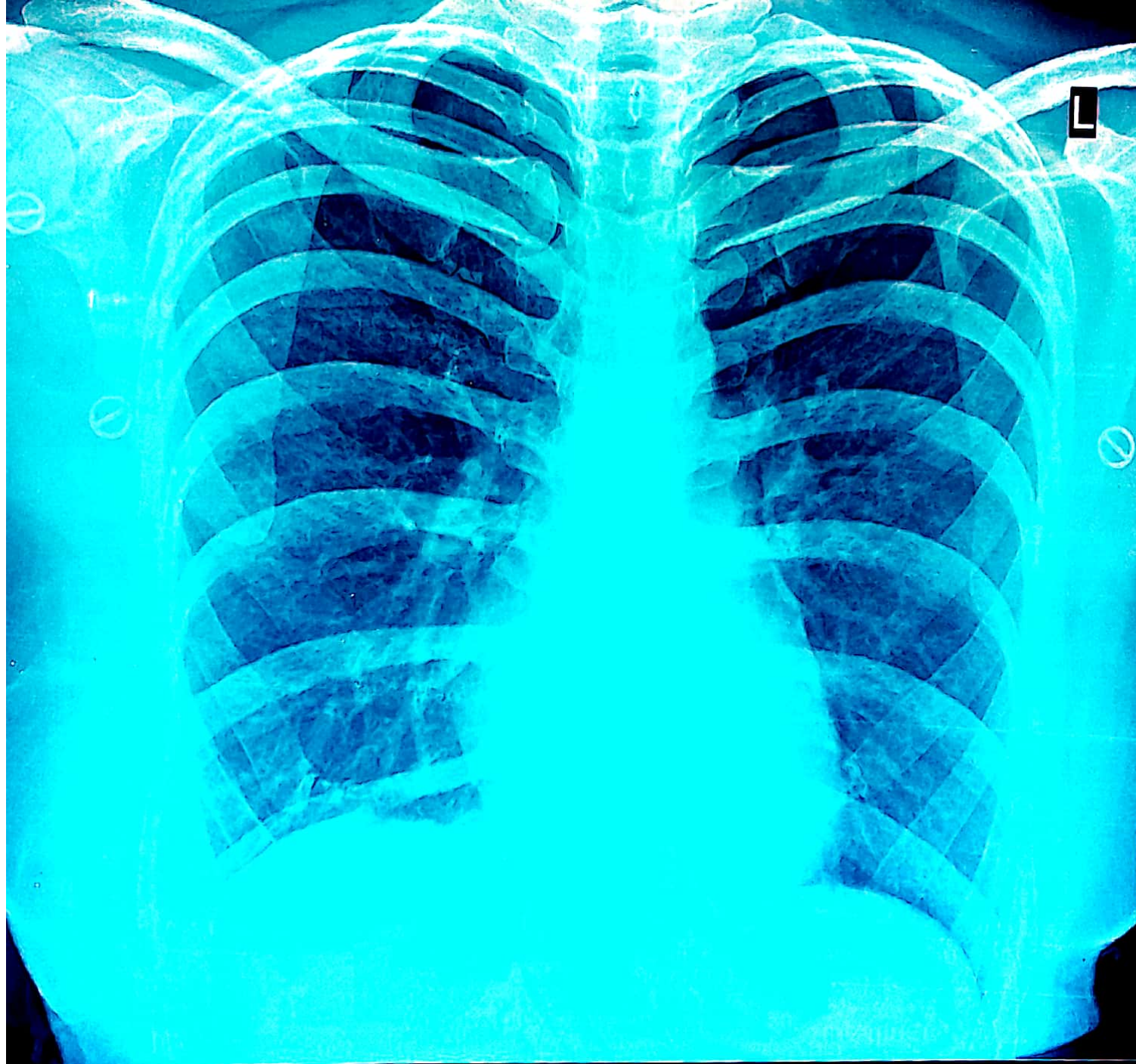
