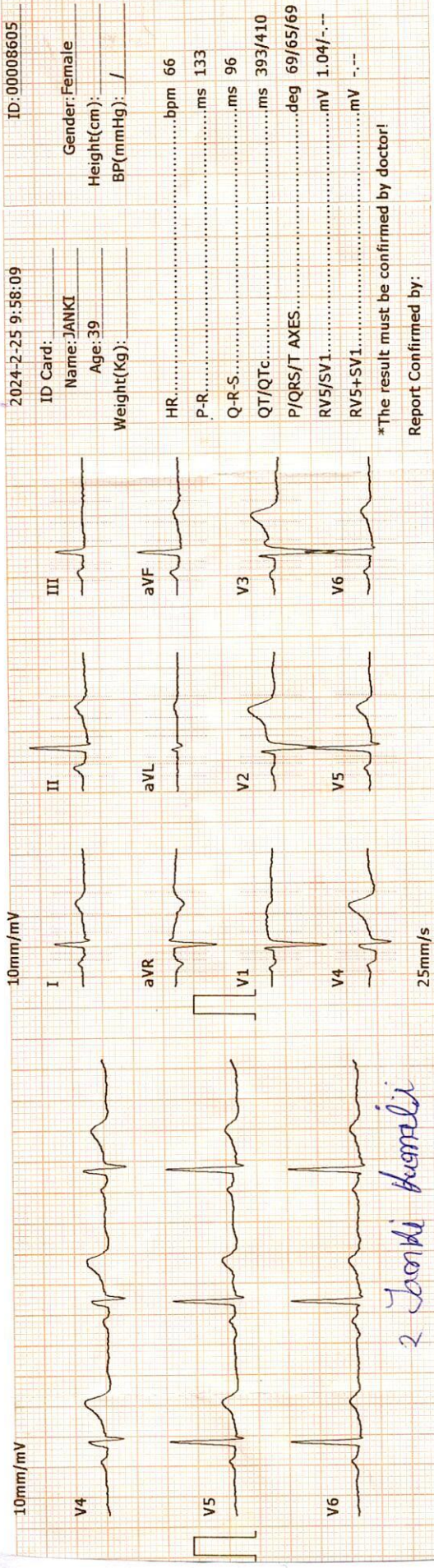
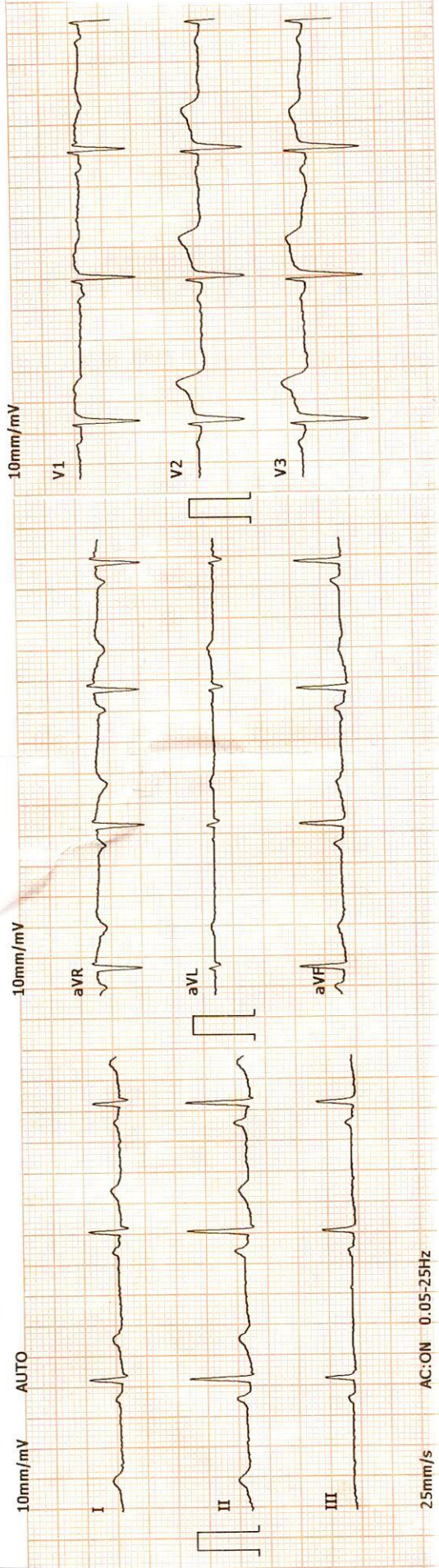

Resting heart rate initially 78 bpm, rose to a max. heart rate of 160 bpm which represents 88% of maximum age predicted heart rate. Resting blood pressure 120/80 mmhg, rose to a maximum blood Pressure of 150/90 mmhg. The exercise stress test was stopped due to Test Complete
