### ULTRASOUND - WHOLE ABDOMEN

**Liver** appears normal in size and mild increased in echotexture. No focal lesion is seen. PV and CBD normal.No dilatation of the intrahepatic biliary radicals.

**Gall bladder** is distended normal. No evidence of calculus. Wall thickness appears normal. No evidence of periGB collection. No evidence of focal lesion is seen.

**Spleen** appears normal. No focal lesion seen. Splenic vein appears normal.

**Pancreas** appears normal in echopattern. No focal/mass lesion/calcification. No evidence of peripancreatic free fluid or collection. Pancreatic duct appears normal.

**Both the kidneys** appear normal in size, shape and echopattern. Cortical thickness and CM differentiation are maintained. No calculus / hydronephrosis seen on either side.

Right kidney measures 99 x 44 mm. Left kidney measures 101 x 45 mm.

**Urinary Bladder** is distended normal and appears normal. No evidence of any wall thickening or abnormality. No evidence of any intrinsic or extrinsic bladder abnormality detected.

**Uterus** appears normal in size measures 60 x 34 x 32 mm. It shows normal shape & echo pattern.Endometrial echo-complex appears normal and measures 6 mm.No intra/extra uterine gestational sac seen.

**Both ovaries** appear normal in size, shape and echotexture.

Right ovary measures 25 x 14 mm.

Left ovary measures 26 x 14 mm.



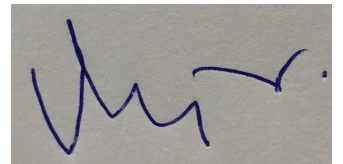
