Interpretation:

- HbA1C above 6.5% can be used to diagnose diabetes provided the patient has symptoms. If the patient does not have symptoms with HbA1C>6.5%, repeat measurement on further sample. If the repeat test result is <6.5%, consider as diabetes high risk and repeat measurement after 6 months.
- HbA1C measurement is not appropriate in diagnosing diabetes in children, suspicion of type 1 diabetes, symptoms of diabetes for less than 2 months, pregnancy, hemoglobinopathies, medications that may result sudden increase in glucose, anemia, renal failure, HIV infection, malignancies, severe chronic hepatic, and renal disease.
- Any sample with >15% should be suspected of having a haemoglobin variant.

U.S.G OF ABDOMEN WITH PELVIS:

LIVER: Appears normal in size and normal echopattern. No focal lesion is seen. No dilated IHBR is seen. PV and CBD at porta appear normal.

GALL BLADDER: Distended and normal. No stone or cholecystitis is seen. Wall thickness is normal.

PANCREAS: Visualized head and proximal body of pancreas appears normal.

SPLEEN: Appears normal in size and echotexture. No focal lesion is seen.

BOTH KIDNEYS: Normal in size and echotexture.
No evidence of stone or hydronephrosis is seen in either kidney.
Cortical thickness appears normal on either side.
Corticomedullary differentiation is maintained in either kidney.

U.BLADDER: Partially distended and appears normal.

UTERUS: Anteverted. Normal in size and normal in echo. No e/o any myometrial lesion is noted. Endometrial cavity is empty.

BOTH OVARIES: No adnexal mass is seen on either side.

No undue dilatation or thickening is noted in visualized bowel loops.
No e/o free fluid is seen in peritoneal cavity.
No significantly enlarged node is seen in mesentery or pre & paraaortic region.

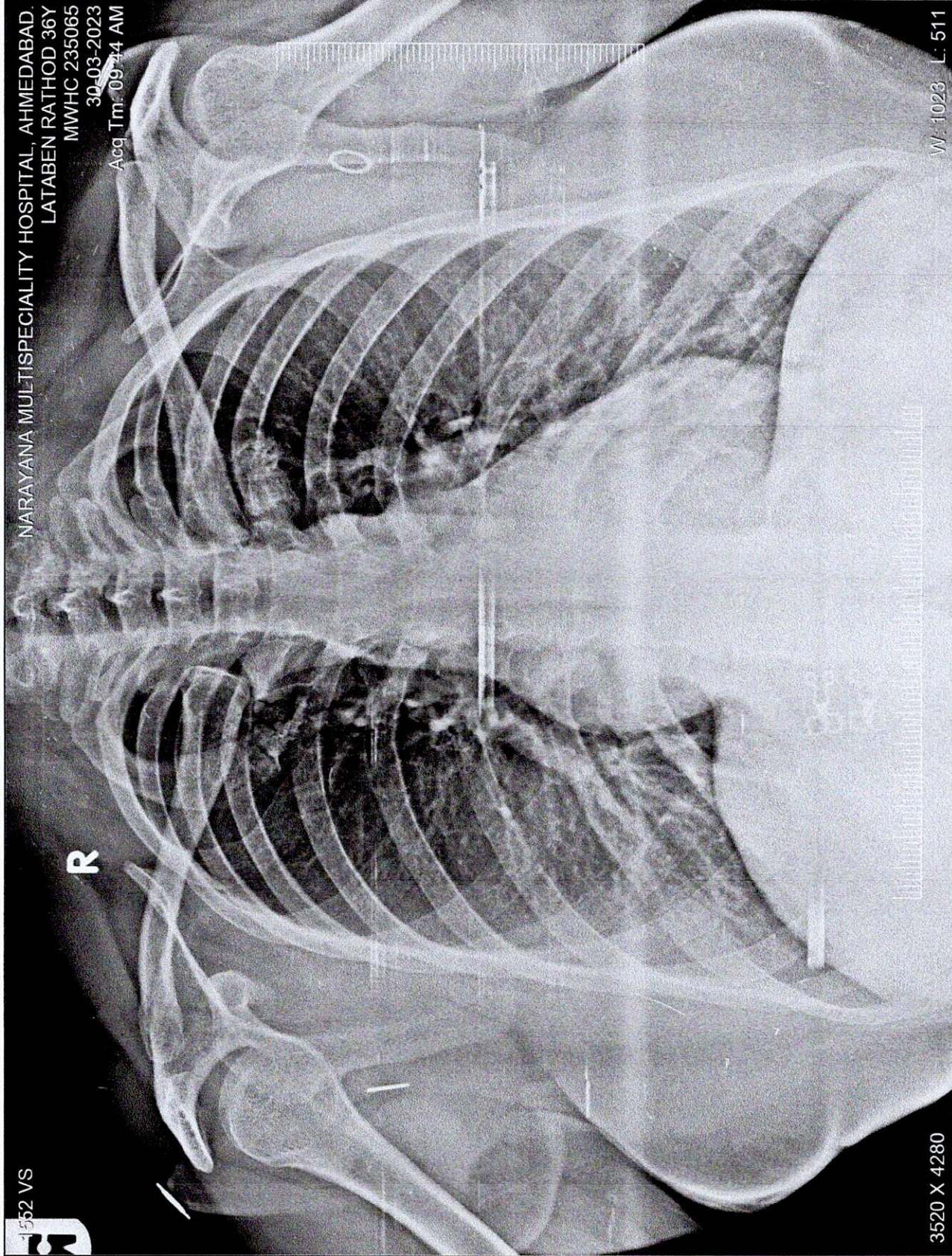
