Note 1. TSH levels are subject to circadian variation, reaching peak levels between 2 - 4 a.m. and at a minimum between 6-10 pm . The variation is of the order of 50% hence time of the day has influence on the measured serum TSH concentrations.

2. Values <0.03 uIU/mL need to be clinically correlated due to presence of a rare TSH variant in some individuals.

INTERPRETATION:

PSA is reliable tumour marker for already diagnosed prostatic carcinomas. It is uniquely associated only with prostatic tissue, and therefore is specific for it. Baseline levels measured prior to therapeutic intervention and followed later by serial periodical measurements will predict the outcome of therapy. It also helps in early discovery of recurrences, relapses and metastases.

1. This is a recommended test for detection of prostate cancer along with Digital Rectal Examination (DRE) and USG in males above 50 years of age.
2. PSA levels may appear consistently elevated / depressed due to the interference by heterophilic antibodies & nonspecific protein binding.
3. Immediate PSA testing following digital rectal examination, ejaculation, prostatic massage, indwelling catheterization, ultrasonography and needle biopsy of prostate is not recommended as they falsely elevate levels
4. PSA values regardless of levels should not be interpreted as absolute evidence of the presence or absence of disease. All values should be correlated with clinical findings and results of other investigations
5. Sites of Non-prostatic PSA production are breast epithelium, salivary glands, periurethral & anal glands, cells of male urethra & breast milk
6. Prostate Health Index , OncoPro Prostate Screen are other recommended assay for PSA levels between 4-10 ng/mL (gray zone). It helps physicians to decide if biopsy is necessary.
7. Physiological decrease in PSA level by 18% has been observed in hospitalized /sedentary patients either due to supine position or suspended sexual activity

Recommended Testing Intervals:

- A. Pre-operatively – Baseline,
 - B. 2-4 days post-operatively
 - C. Prior to discharge from hospital
 - D. Monthly follow-up if levels are high.
 - E. Post-Surgery Frequency of testing
- 1st year every 3 months, 2nd Year Every 4 months and 3rd Year onwards every 6 months


Clinical Use

- An aid in the early detection of Prostate cancer when used in conjunction with Digital rectal examination in males more than 50 years of age and in those with two or more affected first degree relatives.
- Follow-up and management of Prostate cancer patients
- Detect metastatic or persistent disease in patients following surgical or medical treatment of Prostate cancer.

- Prostate cancer, Benign Prostatic Hyperplasia, Prostatitis, Genitourinary infections.
