USG ABDOMEN & PELVIS (SCREENING)(TVS)

Liver appears normal in size & shape with normal echopattern. No e/o focal or diffuse lesion. IHBR appear normal. PV and CBD appear normal.

Gall bladder appears distended & normal in shape & size. No e/o calculus or mass seen. Walls appear normal.

Pancreas appears normal in size and echogenicity. No e/o focal or diffuse lesion.

Spleen appears normal in size and shows normal echopattern. No e/o focal lesion.

Both Kidneys appear normal in size and echopattern. CM Differentiation is preserved. No e/o calculus or hydronephrosis on either side. Perirenal spaces appear normal on either side. Suprarenal regions appear normal on either side. No e/o mass lesion.

Bladder is physiologically distended. No e/o calculus or mass. Walls appear normal.

Uterus appears anteverted, normal in size & shows normal echopattern. Endometrial cavity is empty. ET- 5 mm. No e/o focal or diffuse mass lesion. **Both ovaries** appear normal in size & echopattern. No e/o adnexal mass on either side.

RIF region appears normal.

No e/o ascites.




