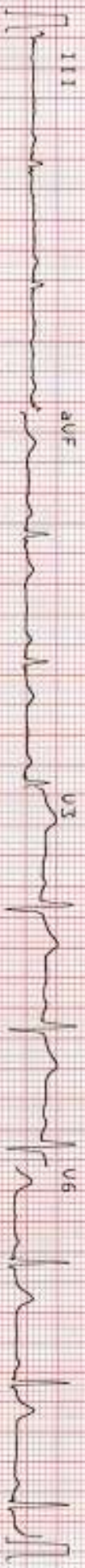
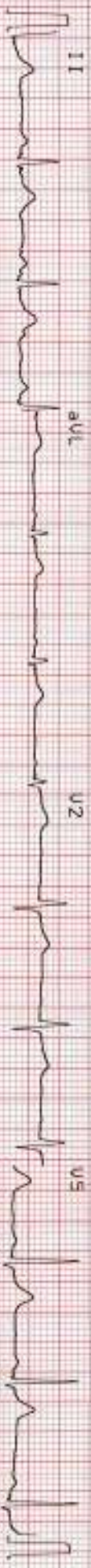
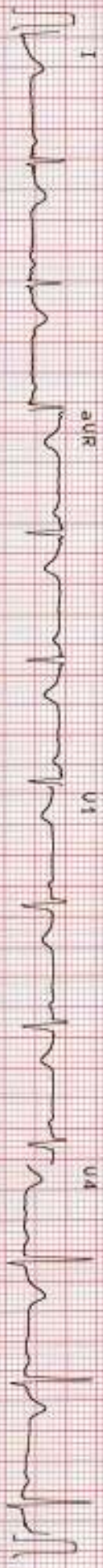

USG WHOLE ABDOMEN

Liver: The liver is normal in size ~ **12.2 cm** and outline. It shows a uniform echopattern. No obvious focal or diffuse pathology is seen. The intra and extra hepatic biliary passage are not dilated. The portal vein is normal in calibre at the porta hepatis (7.6 mm).

Gall bladder: The gall bladder is well distended shows normal wall thickness with no evidence of calculi.

CBD: The CBD is of normal caliber (2.4 mm).

Pancreas: The pancreas is normal in size and echogenicity with distinct outline. No obvious focal lesion is seen.

Spleen: The spleen is normal in size ~ **9.7 cm** and echogenicity.

Kidneys: Both kidneys were normal in position and measured as follows:

Right kidney measures 9.3 x 4.6 cm.

Left kidney measures 9.8 x 4.0 cm.

The renal cortical thickness and corticomedullary differentiation were adequate on both sides. No evidence of renal calculus or hydronephrosis seen on either side.

Urinary bladder: The urinary bladder is normal in size. Its wall shows a smooth outline. There is no evidence of any intraluminal or perivesical abnormality.

Uterus: The uterus is retroverted, normal in size measuring 8.2 x 4.1 x 5.0 cm. Its outline is smooth. It shows normal and endometrial echoes with no evidence of any mass lesion. **Mild free fluid is seen in the pouch of douglas.** Endometrium measures 7.7 mm.

Right ovary measures 2.7 x 1.8 cm **Left ovary measures 2.6 x 2.4 cm**

Both ovaries are normal in size and show uniform parenchymal echogenicity and smooth outline. There is no evidence of any mass lesion arising from or within either ovary.

No evidence of ascites or lymphadenopathy seen.

No pleural effusion seen.
