USG WHOLE ABDOMEN

Liver: The liver is normal in size (**12.8 cm**) and outline. It shows a uniform echopattern. No obvious focal or diffuse pathology is seen. The intra and extra hepatic biliary passage are not dilated. The portal vein is normal in calibre at the porta hepatis (8.6 mm).

Gall bladder: The gall bladder is normal in size, has normal wall thickness with no evidence of calculi.

CBD: The CBD is of normal caliber (3 mm).

Pancreas: The pancreas is normal in size and echogenicity with distinct outline. No obvious focal lesion is seen.

Kidneys: Both kidneys were normal in position and measured as follows:

Right kidney measures 9.7 x 4.9 cm.

Left kidney measures 10.5 x 5.0 cm.

The renal cortical thickness and corticomedullary differentiation were adequate on both sides. No evidence of renal calculus or hydronephrosis seen on either side.

Spleen: The spleen is normal in size ~ **9.8 cm** and echogenicity.

Urinary bladder: The urinary bladder is normal in size. Its wall shows a smooth outline. There is no evidence of any intraluminal or perivesical abnormality.

Prostate: The prostate is normal in size, measures (vol- 20 gms) and showed a normal parenchymal echotexture.

No evidence of ascites or lymphadenopathy seen.

No pleural effusion seen.

- Fatty liver (Grade-I).

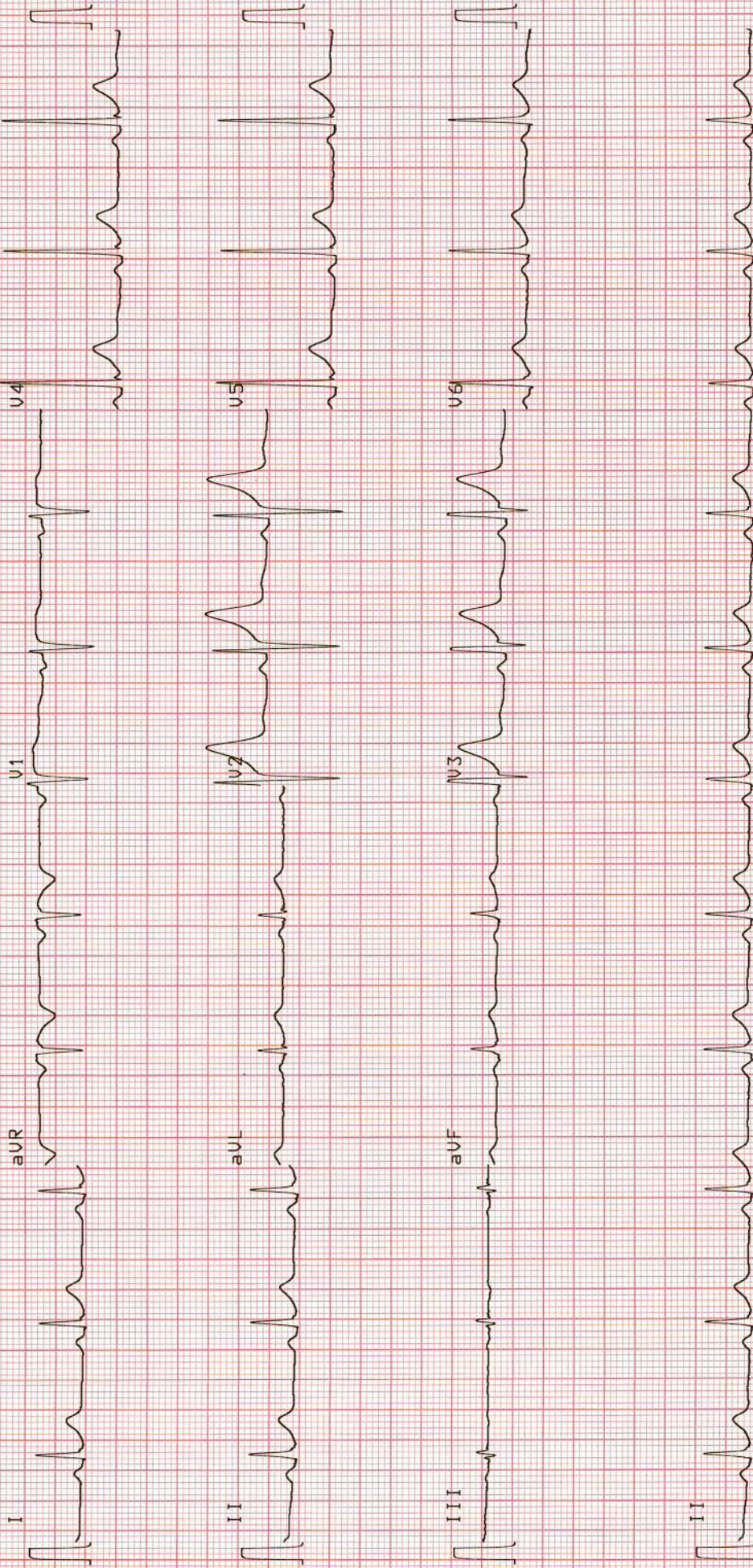

 Description: To rule out to CAD
 INDICATIONS: To rule out to CAD
 PROCEDURE DONE: Graded exercise treadmill stress test
 STRESS ECG RESULTS: The patient was stressed by continuous graded treadmill testing for Exercise Time 6:10 Mins. of the standard Bruce protocol. The initial HR was recorded as 84 bpm, and the maximum predicted Target Heart Rate 183.
 The Test was completed because of **TARGET HEART RATE ACHIEVED**
CONCLUSIONS:
 1. Stress test is **POSITIVE** for inducible ischemia.
 2. Good functional capacity.
 3. Blood pressure response to exercise is normal.
