# Both the hepatic lobes are normal in size and shows moderate increase in parenchymal

# echogenicity S/O grade II fatty liver infiltration (Liver measures 12.5 cm)

Comments:

• Disorders of Lipid metabolism play a major role in atherosclerosis and coronary heart disease.

• There is an established relationship between increased total cholesterol & LDL cholesterol and myocardial infarction.

• HDL cholesterol level is inversely related to the incidence of coronary artery disease.

• Major risk factors which adversely affect the lipid levels are:

- 1. Cigarette smoking.
  - 2. Hypertension.
- 3. Family history of premature coronary heart disease.

4. Pre-existing coronary heart disease.
