WHOLE ABDOMEN:

Both the hepatic lobes are normal in size and show grade I fatty infiltration (Liver measures 12.6 cm)

No focal lesion seen. Intrahepatic biliary radicals are not dilated.

Portal vein is normal in calibre.

Gall bladder is well distended. Wall thickness is normal. No calculus seen.

CBD is normal in calibre.

Pancreas is normal in size and echotexture.
