WHOLE ABDOMEN:

Both the hepatic lobes are normal in size and shows moderate increase in parenchymal

echogenicity S/O grade II fatty liver infiltration. (Liver measures 14.5 cm).

No focal lesion seen. Intrahepatic biliary radicals are not dilated.

Portal vein is normal in calibre.

Gall bladder is well distended. Wall thickness is normal. No calculus seen.

CBD is normal in calibre.

Pancreas is normal in size and echotexture.

- 1. Cigarette smoking.
- 2. Hypertension.

3. Family history of premature coronary heart disease.

4. Pre-existing coronary heart disease.
