WHOLE ABDOMEN:

Both the hepatic lobes are normal in size and echotexture (Liver measures 12.7 cm)

No focal lesion seen. Intrahepatic biliary radicals are not dilated.

Portal vein is normal in calibre.

Gall bladder is well distended. Wall thickness is normal. No calculus seen.

CBD is normal in calibre.

Pancreas is normal in size and echotexture.

Spleen is normal in size (9.3 cm) and echotexture.

Both kidneys are normal in size and echotexture (Right kidney (9.7 cm), Left kidney (10.2 cm). Cortico-medullary distinction is maintained. No calculus or hydronephrosis seen.

Urinary bladder appears normal.

Uterus is anteverted (measures 9.5 x 4.9 x 4.1 cm) and appears normal in size and echotexture. No focal lesion seen. Cervix and vagina are unremarkable.

Endometrial echo is central and normal in thickness (8.2 mm).

Right ovary is normal in size and echotexture. Right ovary measures 3.4 x 1.4 cm,

Anechoic thin walled cyst with no internal vascularity measuring \sim 5 x 3.4 cm seen in left ovary suggesting simple ovarian cyst.

No free fluid or collection seen. No basal pleural effusion seen.

No significant lymphadenopathy seen.

No dilated bowel loop seen.
