WHOLE ABDOMEN:

Both the hepatic lobes are mildly enlarged in size and normal in echotexture (Liver measures 15.8 cm)

No focal lesion seen. Intrahepatic biliary radicals are not dilated.

Portal vein is normal in calibre.

Gall bladder is well distended. Wall thickness is normal. No calculus seen.

CBD is normal in calibre.

Pancreas is normal in size and echotexture.

Spleen is normal in size (11.9 cm) and echotexture.

Both kidneys are normal in size and echotexture (Right kidney (9.5 cm), Left kidney (10.3 cm). Corticomedullary distinction is maintained. No calculus or hydronephrosis seen.
